
Our proprietary web application, LimeBook, is used to digitize business processes.







Problem

Inconsistent and non-uniform communication of post-inspection recommendations to managers of a widespread network of branches and regions.

Faulty implementation of training for management staff, delays in updating current regulations, and a large number of unattended audit recommendations.

LB SHA was selected. Within two months, two main tasks were digitized:

- · reporting on OHS areas
- training managers.

All across several hundred distributed locations.
The system was customized to match the client's established workflows.

Implementation Results

The digitization of the training process for management staff and access to a database of issued certificates (including their validity and expiration dates) has been completed. LimeBook allows for quick adjustments of training materials to accommodate ongoing changes. Reporting, analysis, and decision-making in the area of OHS have been streamlined across a distributed network of approximately 400 branches and the system automates a minimum of 800 audits annually.
